### **Playground Inspection Purpose**

Inspections are conducted by a Certified Playground Safety Inspector for the purpose of identifying safety hazards on playgrounds. Inspections can only ensure the on-site immediate safety of a park or playground.

### **Playground Inspection Scope**

A Soil Express, Ltd. inspection will include the following:

- Safety Hazards—The documentation used to define safety hazards is the most recent publication of the U.S. Consumer Product Safety Commission Handbook for Public Playground Safety and ASTM F1487: Standard Consumer Safety Performance Specification for Playground Equipment for Public Use.
- Qualifications—All inspections will be performed by a Certified Playground Safety Inspector certified by the National Playground Safety Institute.
- Inspected Environment—Play equipment, safety surfacing, fencing, signs, and general environment.
- Report—A complete, photo documented, written report. Reports may be provided via email upon request. The report will include:
  - A description of the overall condition of the playground site. This includes consideration of adjacent and nearby potential for dangerous conditions.
  - An inventory of all playground equipment. Each component will be assessed and reported on. You will be informed if each specific piece of equipment is acceptable or not.
  - Assessment of use zones surrounding all equipment.
  - Assessment of safety surfacing material.
  - Assessment of hazards including identification, classification based on potential injuries, and recommended repairs and/or solutions.
  - Inventory report which serves as documentation for future Inspections.

**PLEASE NOTE:** This will be a comprehensive inspection not a full-scale playground audit.

### **Confidentiality**

We will treat this inspection and any resulting findings as confidential and agree not to disclose this information without your prior authorization.
